

# Navia Freight Cookie Policy

26/03/2021

Navia Freight conducts data collection activities on its own online resources (hereafter, "Websites"), in pursuit of the purposes of the effective continuance of the business activities of Navia Freight, facilitate the exercise of the rights and duties incumbent upon Navia Freight, management of customer relationships in connection with the provision of the freight and supply services of Navia Freight, marketing activities for potential customers of Navia Freight, processing of the data of the employees of Navia Freight and that of the applicants applying to Navia Freight.

Navia Freight, as operator of the Websites available at the URLs <https://www.naviafreight.com/> and [www.naviahub.com](http://www.naviahub.com), sets out the rules relating to the processing of data relating to services rendered as part of the Websites, those who make use of the services available on the Websites, and visitors to the Websites.

Data subjects may provide information and data about themselves on the Websites in two ways:

- personal data may be expressively given or provided in the course of using the services offered on the Websites; or
- information may be provided to Navia Freight in connection with the use of the Websites, visiting the Websites, or use of the Websites.

The following table presents the various types of data processed:

Data collected during use of the Websites	Technical data (IP address of the data subject, date and time of visit, type of browser, addresses of the viewed page and previously viewed pages, which are automatically logged by the system at login and logout.	5 years from the date logged.	Development of the Websites and services. These data are not suitable to identify the Data Subject.	Voluntary consent of the data subject.

For the purposes of providing individualised services, the Websites place small packages of data (hereafter: "Cookies") on the computer of the data subject, and reads these back at subsequent visits. If the browser sends back a previously saved Cookie, the service responsible for managing the Cookie has a way to connect the current visit of the data subject with previous visits, but only with respect to its own content.

Cookies used by Navia Freight;

- Temporary Cookie (Session Cookie): Session Cookies are automatically deleted after the visit of the data subject. These Cookies are used to permit the Websites to operate more effectively and securely, and they are required for certain functions or applications on the Websites to be able to operate correctly.
- Permanent Cookie (Persistent Cookie): Navia Freight also uses persistent cookies to improve the user experience (e.g. to optimise navigation). These Cookies are stored for a longer period in the Cookie directory of the browser. Their duration depends on what settings the data subject has configured in the browser.

The purpose of the Cookies is to distinguish data subjects from one another, to identify the workflow of users, to store data provided by them during use of the site, and to prevent data loss.

The duration of data processing is, for Session Cookies, until the end of the visit to the Websites; for all others, it is until they are deleted by the data subject.

The data subject has a right to delete the Cookies from their own computer and may prohibit the browser from using Cookies.

The Websites may contain references to external servers (not operated by Navia Freight or data processors), and pages accessible by way of these links may place their own Cookies or other types of files on the computer, may collect data, and may request personal data. However, Navia Freight excludes all liability in that regards.

During the placement of Cookies, no personal data is collected or processed, nor is the use or identity of the data subject identified.
